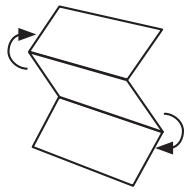

**STAY CALM AND BE POLITE**

- POLICE HAVE MANY POWERS. THEY CAN ASK YOU QUESTIONS, SEARCH YOU OR YOUR PROPERTY, ORDER YOU TO DO THINGS OR ARREST YOU. THEY MAY NOT NEED A WARRANT.



**DO I HAVE TO?**

- IF POLICE ASK YOU TO DO SOMETHING, ASK "DO I HAVE TO?". IF THEY SAY YES, AND YOU DON'T COMPLY, YOU COULD BE CHARGED WITH A CRIMINAL OFFENCE.



**LAWYER PLEASE**

**“ I WANT TO SPEAK WITH A LAWYER ”**


- IF POLICE WANT TO QUESTION YOU, ASK TO SPEAK WITH A LAWYER. CALL LEGAL AID WA BETWEEN 8.30AM AND 4.30PM.

**“ I DON'T WANT TO DO AN INTERVIEW ”**

- YOU HAVE THE RIGHT TO SILENCE. YOU DON'T HAVE TO TELL YOUR STORY NOW. YOU CAN TELL A LAWYER LATER.
